

Certification Exam Registration Guide

If you registered for the exam before the June 30 migration: you already received an email from Pearson VUE with your login details. Please use those existing credentials and follow below steps.

Step 1 — Sign in to Pearson VUE

Sign in at pearsonvue.com/us/en/anthropic with the username and temporary password from the two emails that you would have received earlier from **Pearson VUE** (Pearson VUE sends two emails from **PearsonVUEConfirmation@e.pearson.com**: one with your username (“Web Account Created”), one with a temporary password (“Notice of Automatic Web Account Creation”). They usually arrive shortly after registration — check your spam folder if you don't see them.)

The first time you sign in, Pearson VUE walks you through a short account setup before you reach your dashboard. The exam is delivered by Pearson — not on the Academy site.

Step 2 — Accept the Candidate Agreement

Review Pearson VUE's privacy policy and Candidate Agreement. Check every box, then click Agree. You must accept all terms to continue with registration and scheduling.
